# Vedic mathematics, Science & Technology SOURCE SCRIPTURE

- 0.1 Vedic mathematics, Science & Technology is Ancient Wisdom Discipline of transcendental domain (5-space content lump manifestation permitting transcendence).
- 0.2 Shiv Puran is the complete scripture of Ancient Wisdom of transcendental domains presided by Lord Shiv.
- 0.3 Shiv Puran is the text book of Ancient Wisdom of transcendental domains.
- 0.4Present day knowledge systems as these stand sealed, need be transcended through for transition therefrom. And as such let us learn, comprehend, appreciate and imbibe the values of Ancient Wisdom of transcendental domains to have insight and to be face to face with the values of transcendental domains and to glimpse and avail the virtues of these values.
- 0.5 Transcendental domains chase is a solemn exercise which is naturally going to be of a prolonged consciousness field surfacing. This being so, this attainment is to be approached in an institutional way.

- 0.6Institutionalised learning for transcendental Discipline is expected to be of many phased instructions, study, research and dissemination of transcendental values and acquisition of virtues thereof.
- 0.7The initial phase is to be of instructions and learning of features of hyper cube 5 format.
- 0.8This phase chase is to be the processing values of Sankhiya Nishtha and Yoga Nishtha.
- 0.9 Sankhiya Nishtha presumes the existence of dimensional frames and avails artifices of number, while on the other hand Yoga Nishtha presumes the existence of artifices of numbers and avails dimensional frames.
- 0.10The present phase and stage of transcendental chase, as such is to be as per the values of Sankhiya Nishtha, is to be of format of number 5, while as per the values of Yoga Nishtha is to be of format of dimensional frame of 5-space.
- 0.11 With this, number 5 and hyper cube 5 formats are going to be our basic mathematical tools help for our present phase and stage of initial learning attempt.
- 0.12Shiv Puran enlightens us about two fold values of Lord Shiv expressing as Murti (मूर्ति) and also as Ling 'लिड.ग' / manifested form transcendental hyper cube 5 format form of artifice 5 format.

## STEP – 1 SANKHIYA NISHTHA FORMAT

- 1.1 Sankhiya Nishtha format presumes the existence of geometric formats and avails artifices of numbers format.
- 1.2Sankhiya Nishtha format approach to transcendental (5-space content manifestations) domains, as such is of the values of artifices of Number '5'.
- 1.3 Shiv Puran enlightens us about Idol of Lord Shiv in Murti (मूर्ति) expression as of format values of 5 head lord with each head equipped with three eyes and Lord having 10 beautiful arms.
- 1.4These values expression of 5 heads, 3 eyes of each head, 10 arms are parallel to the geometric format of hyper cube 5 as four fold manifestation layer (3, 4, 5, 6) / (3-space in the role of dimension, 4-space in the role of boundary, 5-space in the role of domain, 6-space in the role of origin) / 3-space content manifestation for dimension fold, 4-space content manifestation for boundary fold, 5-space content manifestation for domain fold, 6-space content manifestation for origin fold)
- 1.5The Idol (Murti) expression values and hyper cube 5 expression values, are parallel to each other as being tabulated hereunder:

Ideal expression	Hyper cube expression
5-heads	5 dimensions
Three eyes in each	Solid dimensional order
head	/ 3-space in the role of dimension / 3-space content format
	for dimension fold
10 arms	10 boundary components
Lord Vishnu	Six head lord, the lord of Lord Shiv
6-space	6-space in the role of origin fold

#### Note

- 1. References from the scriptural text (Shiv Puran) and geometrical format concept features of hyper cube 5, as such are being presumed here, just to indicate the values chase format is going to be the above format.
- 2. However, being conscious of the absolute necessity for such references of scriptural text and explanatory notes about geometric concept and values, the same, hence forth would he duly attended to, to facilitate, Chase of the subject.

# DINANATH BATRA, SENIOR EDUCATIONIST APPOINTED AS EDUCATION ADVISER BY HARAYANA GOVT.

### Personal life

Dinanath Batra was born in 1932 in <u>Dera Gazi Khan</u> in Punjab, in present day <u>Pakistan</u>. He worked as the headmaster of the Dayananda Anglo-Vedic School at <u>Dera Bassi</u> in Patiala district. In 1966, he was appointed headmaster of the Geeta Senior School



in <u>Kurukshetra</u>, the first school set up by the RSS.[3] He is an <u>RSS</u> pracharak.[3]

## **Textbook authorship**

2014. the Bharatiya Janata Party government On 30 June of Gujarat issued a circular, declaring six text books written by Batra to be part of the state education curriculum as supplementary literature.[19] Originally written in Hindi, the books were translated into Gujarati, and were released by Bhupendrasinh Chudasama, the education minister, who stated state that they were compulsory.[19][20] The books carried an endorsement from Narendra Modi, then the Chief minister of Gujarat.
