शिव पुराण (Shiv Puran)

Vedic mathematics, Science & Technology SOURCE SCRIPTURE

STEP – 1 SANKHIYA NISHTHA FORMAT

NOTES

Note 1

- 1. Basic features of IDOL of Lord Shiv have been focused in the Shiv Puran text as Lord with (1) Five heads (2) Ten arms (3) Three eyes in each head,
- 2. One reference is ₹ (1) 13.48 i.e. 48th shaloka of chapter 13 of second (Rudra Samhita part one).

पच्चवक्त्रं दशभुज त्रिनेत्रं वृ"ाभध्वजम् २ (1) 13.48

Note 2

3. Fourth basic feature of IDOL of Lord Shiv being focused in Shiv Puran text (Rudra Samhita part 1 chapter 9) is that seat of Lord Vishnu is in the heart of Lord Shiv.

Note 3

4. The above four features are parallel to three eyes as 3-space in the role of dimension, ten arms parallel to ten components of 4-space in the role of boundary, five mouths parallel to 5-space domain within dimensional frame of five dimensions and seat of lord Vishnu in the heart of Lord Shiv is parallel to 6-space in the role of origin of 5-space.

Note 4

5. The above four fold features of IDOL of Lord Shiv focused in Shiv Puran text together are parallel to four fold features of hyper cube 5 as four fold manifestation layer with 3-space as dimension fold, 4-space as boundary fold, 5-space as domain fold and 6-space as origin fold.

Note 5

- 6. Hyper cube n, may be taken as definition being a four fold manifestation layer (n-2, n-1, n, n+1) / (n-2 space as dimension fold, n-1 space as boundary fold, n space as domain fold, n+1 space as origin fold.
- N=1 shall be leading to hyper cube 1 as four fold manifestation layer (-1, 0, 1, 2).

Note 6

- 8. N=2 shall be leading us to hyper cube 2 as four fold manifestation layer (0, 1, 2, 3).
- 9. N=3 shall be leading us to four fold manifestation layer (1, 2, 3, 4).
- 10. N=4 shall be leading us to four fold manifestation layer (2, 3, 4, 5).
- 11. N=5 shall be leading us to hyper cube 5 as four fold manifestation layer (3, 4, 5, 6).
- 12. Hyper cube 3 as four fold manifestation layer (1, 2, 3, 4) manifests as 'cube'.
- 13. One shall revisit the set up of the cube and comprehend the features of center of cube parallel to origin of 3-space being of the format and features of 4-space set up.
- 14. A step ahead hyper cube 4 accepts 5-space in the role of origin of 4-space.
- 15. With it the first location for 5-space may be comprehended as origin of 4space / origin fold of hyper cube 4.

STEP – 2 ARTIFICES TRIPLE (4, 5, 6)

- 1. Number 5 is of middle placement of numbers triple (4, 5, 6).
- 2. As such, the features of number 5 may be chased as of middle placement of numbers triple (4, 5, 6).
- 3. Beginning with number 4 and reaching uptill number 6 would be the range of such chase of the features of number 5
- 4. Parallel to it the chase range would be of triple spaces range 4-space, 5-space, 6-space.
- 5. This triple spaces range is of the format values parallel to values and virtues of 'TRIMURTI' (overlords of 4, 5 and 6 space) / (Lord Brahma, Lord Shiv, Lord Vishnu).
- 6. This range format would be of range features (hyper cube 4, hyper cube 5, hyper cube 6).
- 7. That way, 5-space as origin fold of hyper cube 4 would be the starting point of chase, and 5-space as dimensional order of 7-space as origin fold of hyper cube 6 would be the reach attainment phase and stage of such chase.
- 8. To have appreciation of such chase, let us be through first chapter of the first samhita and last chapter of last samhita of Shiv Puran.
- 9. Simultaneously let us acquaint ourselves with the transcendental (5-space) code values accepted by the individual letters of Devnagri alphabets and summation values of individual letters availed by the words compositions by the text of Shiv Puran, as the transcendental (5-space) code values of the words compositions for appreciation of their formulations formats as under:-

- **10.** TCV (वेद) = 20, TCV (शिवः) = 25, TCV (प्रयाग)= 14, TCV (आदि) = 14, TCV (व्यास) = 14, TCV (सूत) = 14.
- **11.** The script form of every Devnagri alphabet is of geometric format and the same are of much help to reach at the basics of formulations compositions formats as words of the texts. This aspect as well would be focused henceforth at appropriate places.
- 12. The manifestation range (2, 3, 4, 5), transcendence range (2, 3, 4, 5, 6), the self referral state (2, 3, 4, 5, 6, 7), unit range (2, 3, 4, 5, 6, 7, 8) play their formatting roles in the organization transcendental (5-space) domains.

- 13. The help of symbolic expression for hyper cubes 1, 2, 3, 4, 5, 6 in particular would be taken in terms of the symbols (-, □, ☑, ℑ, ℑ, ◊<)
- 14. Next step shall be concentrating about first chapter of the first Samhita of Shiv Puran and as such one shall be through it as it would help reach at its format for the values of Vedic mathematics, Science & Technology chase.
