शिव पुराण (Shiv Puran)

SOURCE SCRIPTURE

SHIV PURAN

Videshwar Samhita

Chapter – 1

NOTES

- 1. Chapter 1 of Videshwar Samhita, being the first chapter is the initiation values chapter.
- The essence value shaloka, which is of placement prior to the text of chapter 1 itself is:

आद्यन्तमड.गलजातसमानभाव मार्यं तमीशमजरारामरमात्मदेवम् । पच्चाननं प्रबलपच्चविनोदशीलं सम्भवये मनसि शंकरमम्बिकेशम् । ।

- Even prior to the chase of initiation values chapter (chapter – 1) of Videshwar Samhita, the first of seven samhitas of Shiv Puran, one is to glimpse the virtues of above 'essence value shaloka'.
- 4. It shall be giving a transcendental (5-space) feel.

- 5. The essence value shaloka brings us face to face with virtues of transcendental (5-space) domain manifesting as values of five head lord 'पच्चाननं' permitting chase as शंकर 'Shanker' of the whole range of transcendental (5-space) domains from आद्यन्तमड.गलजातसमानभाव beginning to end.
- 6. Four basic words formulations namely (i) आदि Aadi (ii) अन्त Aant (iii) पच्च Panch and (iv) शंकर Shanker, lead us to transcendental (5-space) code values: (i) TCV (आदि) = 10.
- 7. This value is parallel to four fold manifestation layer (1, 2, 3, 4) of hyper cube 3 format and the value 10 is also parallel to 10 components split of creative order (4-space) boundary of transcendental (5-space) domain (5-space) / domain boundry formulation of hyper cube 5 is comes to be A⁵: 10B⁴.
- 8. Further as that 3-space accepts ten directional frame and 3-space as well bring the dimension of 5-space.
- TCV (अन्त) = 14. The value 14 is parallel to four fold manifestation layer (2, 3, 4, 5) of hyper cube 4 further as that 4-space plays the role of dimension of 6-space which as self referral (6-space) boundary (6-space as boundary) of unity state (7-space) manifesting at hyper cube 7 leads to domain boundary Ratio A⁷: 14 B⁶
- 10. TCV (पच्च) = 15
- 11. The value is parallel to $1 \times 3 \times 5$ parallel to dimensional order of 5-space.
- 12. The artifice 15 also accepts re-organization as 15 = 3 + 3 + 3 + 3 + 3, parallel to which would be of the values of dimensional frames of five solid dimensions.
- 13. TCV (शंकर) = 18
- 14. The artifice value 18 is parallel to four fold manifestation layer (3, 4, 5, 6) of hyper cube 5
- 15. Here it also would be relevant to note that Lord Brahma (four heads) sits on a lotus seat of 8 petals and blissfully mediation of transcendental (5-space) lord Shiv and Lord Brahma multiplies as ten Brahmas.
- 16. With this begin for transcendental (5-space) domains chase is to be with mediation upon center of hyper cube 5 which is a seat of 5-space and that the creative boundary (4-space as boundary of 5-space) would emerge as of ten components.
- 17. Such chase shall ultimately take us to the end reach of 5-space as dimension / transcendental (5-space) order of unity state (7-space) manifesting as hyper cube 7 domain boundary ratio A^{4:} 14 B⁶
- 18. This way the attainment would be o exhaustive coverage from beginning to end of the transcendental (5-space) presided by Lord Shiv.
- 19. Here it would be relevant to note that TCV (शिव) = 12 is parallel to split of transcendental (5-space) boundary of self referral (6-space) domain as of 12 components parallel to domain boundary ratio of hyper cube 6 being A ⁶: 12 B $_4$
- 20. Here it also would be relevant to note that one shall blissfully attempt firstly transcend from 3-space to 4-space, secondly from 4-space to 5-space and thirdly from 5-space to 6-space

- 21. This transcendence would be parallel to transition at first step from fire element to air element and as a second step from air element to space element and as third step from space element to Sun element.
- 22. Still further it would be parallel to transcendence as first step at center of cube, as second step at center of hyper cube 4 and as third step at center of hyper cube 5.
- 23. It would be blissful to chase as:
