Transcendence through manifestation is the end process and in terms of it the purification of impurities of hyper cube format stands attained

Chase step 43 Reach from origin into base of origin

1. For purification of impurities of hyper cube format within creator's space (4-space) is attainable by Transcendence through origin fold for its reach at base of the origin fold
2. This reach of Transcendence through origin fold at base fold makes the existence phenomenon of Transcendental format and features
3. This reach is attainable only because of the porous nature of creator's space (4-space) (4-space, as much as that $NVF(\text{porous}) = NVF(\text{four space})$)
4. The Transcendence through origin fold because of its porous nature and spatial dimensional order and emerging reach at base fold makes it the Transcendental phenomenon of solid dimensional order
5. Here it would be relevant to note that creator's space (4-space) being of spatial dimensional order, as such it becomes permissible for the split of a three dimensional frame into a pair of three dimensional frame of half dimensions
6. With it the Transcendence reach uptill base fold is of the format and features of automation in terms of 'half dimension' which is parallel to the format and features of 'frame, frame, frame'.

Chase step 44 Extension of manifestation layers as transcendental
Range

1. The Transcendence process through origin fold attaining reach at base fold, as an end result amounts to extension of four fold manifestation layer into five fold Transcendental range.
2. It is this attainment of Vedic systems which makes the sequential set ups of hyper cubes parallel to the sequential set up of counts of counting numbers and artifices of numbers, which at the present stage of Transcendence through four fold manifestation layers to five fold Transcendental range is of the values of a reach from artifice count / number count four / artifice number count
3. One may have a pause here and permit the transcending mind to continuously remained in prolonged sittings of deep trans and to have a chase further from the format and features of hyper cube 5 to format and features of hyper cube 6 parallel to the format and features of artifice / number / count 5 to format and features of artifice / count / number 6

Chase step 45 Split of Transcendental range as pair of
manifestation layers

1. One of the prominent feature of the five fold Transcendental range is that it permits split into a pair of four fold manifestation layers
2. The five fold Transcendental range $(n, n+1, n+2, n+3, n+4)$ permit split as pair of manifestation layers namely $(n, n+1, n+2, n+3)$ and $(n+1, n+2, n+3, n+4)$
3. As such the ultimate working format of systems and processes of the Discipline of Vedic mathematics, Science & Technology comes to be to work with a pair of consecutive four fold manifestation layers and to attain Transcendental range as an end result.
4. Because of the automation feature of working with half dimension as triple (frame, frame, frame) and NVF (transcendence) = NVF (Self referral) = NVF (Half transcend), like the split of five fold Transcendental range into a pair of four fold manifestation layer, a step ahead the six folds self referral range permits a split into a pair of five fold Transcendental ranges.
5. A step ahead 7 step long unity range shall be permitting a split into a pair of six fold self referral ranges.
6. One may have a pause here and permit the transcending mind to continuously remained in prolonged sitting of trans and to glimpse and to face to face with the format and features of NVF (mathematics) = NVF (Square) + NVF (Cube)
7. Here it would be relevant to note that square as representative regular body of 2-space and as hyper cube 2 within 4-space and further cube as

representative regular body of 3-space and as hyper cube 3 within 4-space, as such become a pair of consecutive four fold manifestation layers namely (0, 1, 2, 3) and (1, 2, 3, 4)

8. Further it also would be relevant to note that 2-space plays the role of boundary of 3-space and that way the working format becomes of the features of simultaneous working with boundary fold and domain fold
9. This in other word would mean to work with space content lumps enveloped within boundaries as geometric envelope.
